### On Preserving the Safety Net

Our 60th Anniversary milestone is a time to reflect upon our achievements and to envision the work that needs to be done. So much has been accomplished in our emancipation from large state institutions to the enjoyment of full lives in the community. From birth, right through the lifespan, HARC offers the full array of supportive services: **early intervention, family support, respite, supported employment, adult day programs, recreation, residential, elderly services, behavioral health and advocacy.** These services came about as a result of the diligent advocacy of our families, that sometimes required costly lawsuits, both in time and money.

While truly a cause for celebration, it is critical to point out that these supportive services are provided at the discretion of state and federal government. **THERE ARE NO GOVERNMENTAL ENTITLEMENTS TO THESE SERVICES.**

While entitlement programs are clearly out of favor with many politicians, from my perspective, they are **IN FAVOR** when they provide critical health, safety and quality of life for our people. If not for us, then for whom?

The only entitlement that people with intellectual disability enjoy is mandatory education from the ages of 3-21. This entitlement came about following class action litigation resulting in the passage of The Education for All Handicapped Children Act, PL 94-142, later renamed, the Individuals with Disabilities Education Act. **All other services are provided at the discretion of state and federal government. Funds may be eliminated or reduced at any time, especially in this political climate.** Just recently, we witnessed the elimination of family case management.

We applaud Governor Dannel Malloy's and many of our legislators' efforts to preserve Connecticut's safety net by maintaining funding for government - supported programs that serve fragile people. However, it is important that they hear from you regarding the importance of these services to you and your family.

We need your help by remaining vigilant to the critical services that are needed for our sons and daughters, sisters and brothers. Please visit our web-site **www.harc-ct.org** and share your email addresses so that you can join our families in contacting your elected officials to preserve the Safety Net. With your advocacy our mission will be accomplished.


